



Filing False or Misleading Applications—

Question 3 of Part F of the application for a limited permit or license to practice respiratory care and on the application for renewal of a limited permit or license asks: “Have you ever been convicted of any felony or misdemeanor offense in violation of any Federal, State, or Municipal Ordinance?” All applicants are required to answer this question and complete the application under oath. Obtaining a license or limited permit by means of a false or misleading representation is grounds for refusing to issue, revoking, or suspending a license or limited permit or putting a licensee or limited permit holder on probation with a fine and other consequences. O.R.C. 4761.09 (A)(4). Furthermore, making a false affidavit is a first degree misdemeanor in the State of Ohio, which could subject the licensee or permit holder to criminal prosecution as well. O.R.C. 2921.13.

All criminal convictions, except minor traffic misdemeanors must be reported. Offenses where jail is possible, such as driving under the influence, driving under suspension and leaving the scene of an accident are not minor. The Board has reviewed applications of persons that have reported prior convictions and, in most of these cases from my point-of-view, has been fairly liberal in issuing licenses and limited permits. Unfortunately, there has been a recent glut of cases where applicants are falsely swearing under oath that they do not have a criminal record when, in fact, they do. No less than six such cases were in various stages of consideration for this very issue at the Board’s October 2009 meeting.

The Board does not overlook this infraction. At a minimum anyone who is found to have violated the full disclosure requirements will have a disciplinary record and will be required to pay a substantial fine.

Pay attention to your application. If you have any doubts as to what needs to be reported, telephone the Board office at (614) 752-9218.

If you have already made a false report, self-reporting before you are caught is a mitigating factor that can positively affect your case. If you have any questions you are urged to seek independent legal advice. The Board cannot fulfill its duty to only license qualified applicants, when the applicants falsify their applications. Full disclosure is essential. The Board takes this responsibility seriously and you should too.

Elimination of I.D. Cards Beginning 2010

Beginning this year, the Board will no longer issue License and Limited Permit wallet I.D. cards upon completion of the license or permit renewal process. After an intense period of review and a public rules hearing, rules 4761-7-01 and 4761-8-01 of the Administrative Code were amended to permit the Board to have the option of issuing a wallet I.D. card or, in lieu of a wallet I.D. card, use on-line license verification through the Board's website as proof of current authorization. For licenses and permits effective on or after July 1, 2010, the on-line electronic "license verification" website provided by the Board on its website shall serve as the official verification of licensing status.



The Board believes this change is a more sound method of providing licensing status information to licensees, employers and the public. Wallet I.D. cards are paper based and they can be forged, altered, misappropriated, and they do not reflect recent disciplinary action taken. The on-line license verification system is current, and reflects the computerized record of the licensee maintained by the Board.

So what can a practitioner expect upon renewal? Upon payment of the correct fee and completion of an on-line or paper renewal application, the Board will update the status information for each licensee indicating that your renewal payment has been received and that your renewal is being processed. The status will state, "ACTIVE IN RENEWAL—PAID." Licensees can view and print this information by checking their status on the Board's on-line license verification system. Following license or limited permit renewal, respiratory care providers may access the website by following these directions:

1. Go to www.respiratorycare.ohio.gov.
2. Click on "License Verification" found under the title "Information" on the right hand side of the page.
3. Enter search criteria. **Use narrowly search criteria.** You could enter only your last name, but your license number is the best search criteria. If using license number enter your credential type in the first box (RCP for licensees, L1 for students or L2 employment based limited permit holders). In the next box enter your license or permit number.

For example: License Number .

4. Click "Search"

Ohio Law Requirement on Continuing Education

New rules implemented on July 1, 2008 require all licensee to complete 20 contact hours of continuing education every biennial renewal cycle and for some limited permit holders (issued under ORC 4761.05 (B)(1)(b)) to complete 10 contact hours of continuing education each annual renewal. Continuing education earned for license or limited permit renewal must minimally include the following content requirements:

(1) An applicant for license renewal shall complete twenty contact hours of relevant RCCE every two years, beginning with the license renewal date and ending on the license expiration date established under division (D) of rule 4761-7-01 of the Administrative Code, unless the applicant meets a waiver provided for in rule. RCCE earned for license renewal must include the following content requirement:

(a) One contact hour of RCCE on Ohio respiratory care law or professional ethics as set forth in rule 4761-9-04 of the Administrative Code; and

(b) At least fifteen of the required contact hours must include content relating to the provision of clinical respiratory care as defined under section [4761.01](#) of the Revised Code; and

(c) The remaining four contact hours may include indirectly related content, including, but not limited to, activities relevant to specialized aspects of respiratory care, such as education, supervision, management, health care cost containment, cost management, health quality standards, disease prevention, health promotion, or abuse reporting.

(2) An applicant for renewal of a limited permit issued under division (A)(1)(c) of rule 4761-6-01 of the Administrative

Code, shall complete ten contact hours of relevant RCCE every year, beginning with the limited permit renewal date and ending on the limited permit expiration date established under division (E) of rule 4761-7-01 of the Administrative Code, unless the applicant meets a waiver provided for in rule 4761-9-02 of the Administrative Code. RCCE earned for limited permit renewal must include the following content requirement:

(a) One contact hour of RCCE on Ohio respiratory care law or professional ethics as set forth in rule 4761-9-04 of the Administrative Code; and

(b) At least seven of the required contact hours must include content relating to the provision of clinical respiratory care as defined under section [4761.01](#) of the Revised Code; and

(c) The remaining two contact hours may include indirectly related content, including, but not limited to activities relevant to specialized aspects of respiratory care, such as education, supervision, management, health care cost containment, cost management, health quality standards, disease prevention, health promotion, or abuse reporting.

Waiver provisions:

A first time license holder in the state of Ohio who has been licensed for more than six months, but less than one year from the license expiration date must complete at least ten contact hours of continuing education, including one contact hour on Ohio respiratory care law or professional ethics. First time license holders who have held a license for less than six months from the biennial license expiration date will not be required to complete the RCCE requirements for the current term of collection, but will have to complete the RCCE requirements for the next biennial renewal period.

A request to waive the RCCE requirements may also be filed and a waiver granted for either of the following:

(a) The applicant has been absent from Ohio for more than one half of the term of collection for the authorization type held due to military service;

(b) The applicant has been prevented from completing the RCCE requirement due to documented proof of a medical disability for more than one half of the term of collection for the authorization type held.

Medical or Professional Ethics Courses:

Of the hours required, the new rule states that one (1) contact hour must include education in medical or professional ethics or laws regulating the practice of respiratory care. The Board has approved many continuing education courses that meet the medical or professional ethics requirement. These courses are generally individual course offerings. The Board; however, offers one (1) free contact hour on Ohio laws or rules regulating the practice of respiratory care. The Board has contracted with Quia.com to offer this course. Here's how it is done:

1. Go to the Quia website at <http://www.quia.com/web>. Select, "Student Zone." When the next page appears, click the button labeled, "Create my free account."
2. Select, "Student" as the account type.
3. Fill out the form that appears using first initial and last name as the user name. Quia will provide a password for your account.
4. When done, press the, "Create my account" button. (Write down the username and password for future reference. The Board does not collect password data.
5. After enrolled, type the [six-character] QUIA class code provided on the Ohio Respiratory Care Board's course listing site that corresponds to the course to complete and push the "add class" button. When the class name, instructor name, and "Class page" appear you may view the class page to do the module. Click on the "[http://quia.com/pages/\[program title\]](http://quia.com/pages/[program title])" link next to the word "Class page."
6. The quiz is at the end of the class material. Click on the link for the quiz and answer the questions. **USERNAME AND PASSWORD ARE REQUIRED TO TAKE THE QUIZ.**
7. If quiz score is greater than 70% it is successfully completed.
8. Print a copy of the score/results page to use as "the certificate of completion." Make sure to sign the score sheet and record the date of completion on it. **Please note that the score sheet does not look like a traditional certificate of completion.**

Online Renewal for Licensed Respiratory Care Professionals

Online renewal of your respiratory care license is the Board's preferred method of processing your license renewal! Online license renewal allows you to:

- Renew your license, at your convenience, 24 hours a day, 7 days a week.
- Pay your renewal fee with your Visa or Master Card.
- Complete your renewal accurately, without hassle.

Receive an immediate online receipt and email verification of your renewal.

To renew your license online, go to <https://license.ohio.gov>, select the "License Renewal" link, and follow the online instructions. If you cannot finish the process in one sitting, the licensing system will save the information you entered and allow you to logon later to continue. To renew online, you will need to have the following information prior to entering the system:

- Your online user ID (printed on your renewal form);
- Your online password (printed on your renewal form);
- Your Ohio license number (printed on your renewal form);
- Continuing Education information, including course title, date of completion, number of earned contact hours, and the accrediting organization. **You cannot renew without this information.**
- Your email address to receive confirmation and receipt;
- Your Visa or Master Card.

If a licensee cannot renew on-line or would rather file traditionally, the licensee will be asked to complete a PAPER APPLICATION REQUEST FORM and mail or fax it to the Board. A paper form will not be mailed to the licensee without completing a PAPER APPLICATION REQUEST FORM.

Online Status Definitions

License statuses:

Active—The authorization is fully active and the individual is permitted to practice in Ohio.

Active in Renewal— The authorization is fully active, the person is in the process of renewal.

Active in Renewal Paid— The authorization is fully active, the person is in the process of renewal and has paid the fee requirements.

Active in Renewal Incomplete— The authorization is fully active, the person is in the process of renewal, but something part of the renewal requirements have not been demonstrated.

Active in Renewal CE Pending— The authorization is fully active, the person is in the process of renewal, but failed to report all of the CE requirements needed for renewal.

Inactive— The individual has advised the Board that they do not intend to practice in Ohio and have requested inactivation of their license.

Expired—A licensee failed to renew the license and lapsed following the listed expiration date for the license or permit.

Suspended— The authorization type is suspended and the individual is not permitted to practice in Ohio until the term of suspension is over.

Permanently Revoked— The individual's license has been withdrawn by a action of the Board. The individual cannot practice in the state of Ohio.

Board Membership Changes

Kenneth Walz, J.D., R.R.T., R.C.P., N.P.S. was appointed to the Board on March 14, 2009. Mr. Walz is a graduate of the University of Toledo, School of Respiratory Therapy. After graduation, Mr. Walz continued on with his education, earning a degree in law from the University of Toledo. Mr. Walz is a practicing attorney, but still works as a therapist on occasion. His background and experience makes him a welcomed addition to the Board.

Medicare announces timeline for competitive bidding for Durable Medical Equipment

Durable Medical Equipment suppliers are required to bid with Medicare to be considered for supplier contracts. The bids to serve Medicare patients in the Cleveland MSA and Cincinnati MSA were due December 21, 2009. The Medicare Competitive Bidding Program was established under the Medicare Modernization Act of 2003. Under the bid program, durable medical equipment providers are required to submit their lowest cost bids in 7 product categories. Medicare will evaluate the bids and award supplier contracts in 9 competitive bidding regions throughout the United States.



The program was implemented on July 1, 2008, after bids were submitted by durable medical equipment providers earlier that year; however, the program was delayed by congress due to concerns about the bidding process. The new round of bidding, which closed this month is for a three year award beginning January 1, 2011. Medicare intends to evaluate bids during 2010 and contract with suppliers during the summer.

Only accredited durable medical equipment suppliers will be considered for bid awards. The Center for Medicare and Medicaid Services requires accreditation to serve Medicare patients.

Ohio Respiratory Care Board staff report that they have observed an increase in the number of out-of-state home medical equipment applications for certificates of registration. Ms. Tatum, the Board's HME Manager states, "There is not a day that goes by that I do not receive a call from an out-of-state home medical equipment vendor seeking to do business in the state of Ohio due to competitive bidding." Ms. Tatum reported that an upswing in applications occurred in 2008, when the Medicare's Competitive Bidding Program was to have started.
